Can I get a VAT refund at Madrid Airport?

There is no minimum amount required to be eligible for a VAT refund at Madrid Airport. Although Spain had a minimum amount of money per purchase as a condition for tax-free shopping, this rule has changed. Currently, non-EU travelers are entitled to a tax refund regardless of the purchase amount.

How do I get a VAT refund in Spain?

After validation, head to the refund counter (Global Blue/Planet) to receive your refund (cash or card; fees may apply). Connecting flights: If Madrid is your final EU exit, validate here; otherwise validate at your last EU airport. Spain uses VAT (IVA), standard rate 21%. Eligible non-EU visitors can claim a VAT refund.
